

KEYLESS LOCKING OPTIONS



MECHANICAL PUSH BUTTON.....

- Simple five button mechanical lock that requires no batteries
- Does not track user access or provide audit trail info
- Reprogramming the combination is done manually at each cart



ELECTRONIC KEYPAD.....

- 10 button electronic lock that requires batteries (Six D cells)
- Accomodates 250 individual users and tracks last 1,500 unlock events
- Auto-relock function will automatically lock the cart after a preset amount of time (default is 10 min)
- Reprogramming user access codes is done manually at the cart via the keypad or at each cart via laptop running Lockmanager software
- Laptop plugs into the cart's dataport to add/delete user access codes, change auto-relock time and/or access audit trail information
- Lockmanager software is STRONGLY recommended for maintaining a fleet of a carts (Only one copy needed per facility - approximately \$500)
